- 2. Continuous Professional Development available for all employees which includes First Aid and Child Protection/Safeguarding Training that is renewed every 3 years
- 3. Read and understand our Health and Safety policy
- 4. Read and understand our Safeguarding policy
- 5. Undergo a full and robust induction with the company

All employees at First Step Education & Training are subject to repeat DBS checks every 3 years and all carry identity badges with a photograph to identify themselves on site which will be available for your school/venue to photocopy at any time.
